

Dedication Sct — Dedication ceremonies for the official opening of the rehabilitation workshop at Rancho Los Amigos at Hondo, a work project for handicapped people attracting nationwide attention, are scheduled to start at 1 p.m. today. The State Department of Education and the County Charities Department are sponsoring the project.

Bergen Files Suit — Edgar Bergen, the controlling factor in Charlie McCarthy's life, filed suit in Superior Court to eject a tenant from a storeroom he owns at 6540 Sunset Blvd. The radio ventriloquist asserts that the tenant, Charles Erkman, failed to pay the \$300 monthly rent due last Feb. 15.

Litigation Settled — Clearing the way for establishment of a park and municipal golf course on the site of the Rancho Golf Club fronting on Pico Blvd., long-pending litigation was reported settled in Superior Judge Caryl M. Sheldon's court for \$200,000 to be paid by the city. The litigation was started by the Federal government, which sought clear title to the 186-acre iract, taken over from the Rancho Golf Club in settlement of a claim for income taxes. Under the settlement, the city will take title upon payment of \$200,-000 to the Collector of Internal Revenue.

Commandant Named—Naval station at Port Hueneme has a new commander—Commodore O. O. Kessing, U.S.N., a veteran of the Pacific, who relieved Commodore W. M. Quigley, reported soon to come up for retirement. Simultaneously with the shift of commands, Capt. B. W. Brink was announced as new civil engineer officer in command of the construction battalion center at Port Hueneme. He relieved Capt. H. B. Jones, who goes to the staff of Adm. John H. Towers, commander-in-chief, United States Fleet.

Churchill Idea Scored—There will be an unfavorable reaction throughout the Orient to Winston Churchill's speech this week advocating a British-American military alliance, in the opinion of Diosdado M. Yap, Philippines editor. He said upon arrival here that Churchill's idea is nothing more than the old al-

United Electrical, Radio and Machine Workers' strike at U.S. Motors last January.

Ambrose found Roderick John Elmore, a picket on the line when the film strike riot took place at Warner Bros. studio last October, guilty of carrying a concealed blackjack. The judge set next Monday as time to hear a pichation report and to fix sentence.

"Negotiator Named—The A.F.L. Screen Extras' Guild, which last Sunday was elected collective bargaining agent for motion-picture extra players, has engaged Lawrence W. Beilenson as negotiator. Beilenson has had long experience as an attorney for unions in the industry. Henry B. Ely is to continue as general counsel. Nominations for offices in the guild will close April 15, ballots will be mailed to members May 1 and must be returned by May 10.
