REFORM SOUGHT BY CODE GROUP

City Building Departments Free of Politics Aim

Examination Provision Put Into Proposed Rules

Non-Permit Structure List Also Given Approval

City building departments free from political influence was an end toward which the executive committee of the Uniform Building Code, California edition, directed its efforts yesterday at a meeting in the Citizens' National Bank Building.

The committee is surveying a tentative final draft of the code, which, it is hoped, will be adopted throughout the State on its completion. Numerous sections of the code have been put into force in many municipalities and one section is being used as a guide by the State architect in passing on scholo construction.

PROVISION FOR TESTS

Yesterday, the committee sought to guard against political appointments by adopting a provision requiring candidates for posts of supervisors to pass examinations. Fower of suspension was vested in the building department head, with procedure outlined for an appeal to an examining board.

an examining board.

The committee also passed on various types of structures for which permits might not be required, among them being flag poles, small storage tanks, fences less than six feet in height, counters not more than four feet in height, certain other store flutures, fountains and low partitions.

MOTION-PICTURE SETS

Motion-picture sets not on or supported by buildings might be erected without permits. For reasons of public safety, however, it was declared that sets erected on buildings should be supervised in their erection.

Zoning was recognized as an important problem and Chairman David J. Witmer said the committee later intends to draw up a model zoning ordinance. For the time being, however, it was decided not to incorporate zoning regulations in the general code.
